- 1 The desirous candidates who meet the requisite qualification, experience and age criteria may apply on the application form available on the website [nhmharyana.gov.in](http://nhmharyana.gov.in) & [haryanahealthhisar.in](http://haryanahealthhisar.in)
- 2 Only prescribed application duly completed in all respects (including full particulars, complete postal address with pin code, contact number & e-mail address clearly mentioned) along with two recent colored passport size photographs, self attested copies of Educational qualification, Relevant Experience Certificate/Documents and Residence Proof should reach/be submitted in the respected office of Civil Surgeon, Hisar Haryana by 24-04--2023 up to 4 PM
- 3 Application received by any means after 4 PM on dated 24.04-23 will be rejected.
- 4 For any type of information such as short listed candidates candidate list/notice must visit on the website [nhmharyana.gov.in](http://nhmharyana.gov.in) & [haryanahealthhisar.in](http://haryanahealthhisar.in)
- 5 Selection Committee/Appointing Authority will not be responsible any postal delays in delivery of applications.
- 6 The candidates must encircle the name of the post and category applied for on the top of the application form & on the envelope in bold letters.
- 7 Numbers of posts can be increased/decreased or can be completely withdrawn without prior information or corrigendum as per the decision of the chairman of this programme.
- 8 Reservation policy of Haryana Govt. will be followed.
- 9 Original documents in support of academic Qualification and work experience etc. shall be required to be produce before the written test.
- 10 The recruitment will be strictly area specific for Distt. Hisar only. All the posts are NON-TRANSABLE and selected candidates will remain posted at the place of appointment.
- 11 Selection Committee/ Chairman has right to reject any application if found improper.
- 12 The candidature of the candidates will be purely provisional and will be subject to screening test/computer skill test, interview/joining duty. If it is found that the candidate does not fulfill any of the eligible criteria or information furnished by the candidate is incorrect or false, his/her appointment on contract will be terminated immediately without any notice.

- 20 Distt. Authorities has right to reject any application if found incomplete or having cuttings or misleading information.
- 21 Any information provided by the application if found false or misleading at any stage of recruitment as well as after recruitment, the contract of such candidates will be terminated without giving any notice further notice and appropriate action including FIR, Court case etc. will be initiated against them.
- 22 Selected candidates shall not have any claim for regularization of his/her service based on the duties performed under this contract, as he/she has been engaged for project financed by Government of India having specific tenure.
