- The <u>Selection Criteria</u> for the recruitment under NHM has been issued by o/o Mission Director NHM Haryana vide office letter no. NHM/Admin/HRC-1/2025/4306-26 dated: 06-05-2025 and SOP for NHM Recruitment has been issued vide office letter no. NHM/Admin/ HRC-1/2025/4065-85 dt: 25-04-2025, will be followed for recruitment.
- <u>Waiting list</u> will be prepared as per guidelines received Vide email No. 1/892-NRHM/A-6/Misc/2011/4577-97 dt: 12.05.11 of Mission Director (NHM) Haryana, Panchkula and it will be valid for 6 months.

Benefit of reservation

- The benefit of reservation will be given only to those DSC(Deprived Scheduled Caste) or OSC(Other Scheduled Caste, BCA (Non Creamy Layer)/BCB (Non Creamy Layer), EWS, ESP, PwD and ESM candidates who are bonafide residents of State of Haryana. The reserved category candidates belonging to other States will be considered as general category candidates. Reservation certificates should be issued in current financial year.
- The candidates belonging to BCA(Non-Creamy Layer)/BCB(Non-Creamy Layer) categories are directed to obtain the fresh/latest BCA or BCB certificate, as the case may be. This certificate should have been issued on or after 01.04.2025 & on or before Walk-in-Drive for document verification. BCA & BCB candidates of Haryana who fall in the creamy layer as specified by the Government of Haryana are not entitled for the benefit of reservation and they would be considered as General category candidates for all intents and purposes. The BC-A/BC-B certificate issued for contesting the Panchayati Raj Elections shall not be considered. OBC certificate issued for jobs in Central Govt. shall not be considered. The certificates issued in the required performa will only be considered.
- EWS certificate valid for State of Haryana on prescribed performa should be valid for the year in which the candidates have applied for the posts. The EWS certificate should have been issued on or after 01/04/2025 and on or before Walk-in-Drive for document verification.
