## Process to be followed by Civil Surgeon's/ outsource agency for hiring of drivers and EMTs to be deployed on ambulances:-

- Civil Surgeon will request the outsource agency to provide list of Drivers and EMTs, three times of the vacancy as per the reservation policy of the State.
- The committee constituted by Civil Surgeon and outsource agency representative will verify the documents provided by outsource agency and prepare merit list according to selection criteria.
- In case of drivers, Civil Surgeon will send the driving license of the eligible candidates to Regional Transport Office (RTO) for verification of genuineness of Driving License.
- Civil Surgeon will request the Transport Department to conduct the driving test of all eligible candidates. The candidates who fails in driving test will be rejected immediately.
- Committee constituted by Civil Surgeon will prepare a merit list for Driver and EMT as per the selection criteria of Drivers and EMTs.
- Finalized merit list of drivers and EMTs will be shared with outsource agency to issue appointment letter to the candidates having higher scores as per the selection criteria and deploy them on the ambulances.
- Outsourcing agency providing drivers and EMTs will give detail of salary, deduction of EPF and account in which salary is credited of each month to Civil Surgeon before 7th of every of month. If details not provided, Civil Surgeon is competent authority to take necessary disciplinary action against outsourcing agency.
- Persons engaged under outsourcing policy part - I and part - II should be issued identity card by the concerned Department only after obtaining the police clearance i.e. subject to clearance above their character and antecedents.
- The service provider shall recommend only those persons for engagement whose police clearance/verification about character and antecedents has been obtained.
